

The iPaaS Integration Service is part of the SEEBURGER Business Integration Suite (BIS) software solution, which offers the following core functionality:

- > Processing of all asynchronous integration processes between your backend systems, business partners and other applications
- > Automatic exchange of data with your EDI partners
- > Support for all EDI protocols and formats
- > Support for asynchronous EAI and API requests
- > Translation of documents into the supported exchange formats
- > Automatic delivery of the converted documents
- > Provision of a monitoring view for your department
- > Provision of a front-end configuration tool for your integration team

SEEBURGER takes the requirements of different industries into account by using ready-made modules that map the integration-specific processes, standards and special features.



The iPaaS Integration Service is extremely flexible. It does not matter which communication protocol and which data format you or your business partner prefer. You can choose between different operating models: Combine very economical, standardized public or private cloud models of different characteristics with individually-agreed service level modules. We also support hybrid cloud models, where we flexibly combine partial functionalities of our iPaaS Integration Service with your on-premises solution.

All process, configuration and master data, as well as all translation rules (mappings) and processing rules, are automatically monitored and logged at all times.
